INTRODUCTION

The management shall appoint Muslim halal executive officer or establish a committee which consist of Muslim personnel who are responsible to **ensure the effectiveness in implementation on internal halal control system.**

The management shall ensure that sufficient resources (i.e. manpower, facility, financial and infrastructure) are provided in order to implement the halal control system.. **These two requirements under clause 3.1 Management Responsibility stressed on the implementation of halal control system. Halal control system is one of the core element for Malaysia Halal Certification. Halal Control System mentioned in MS 1500 is also known as Halal Assurance Management System (HAS) in Manual Procedure for Malaysia Halal Certification Requirements & further explained in Guidelines for Halal Assurance Management System (HAS).**
